#### Important Information about **Debit Card Courtesy Pay**

Courtesy Pay is a convenient service and benefit that is added to your checking account that provides an added layer of protection in the event you need to use it. Beginning July 1, 2010, we will no longer be able to authorize and pay overdrafts for your one-time debit card transactions without your affirmative consent (opt-in). Below are important FAQ's to help explain the changes.

#### Q. What is a one-time debit card transaction?

A. Whenever you swipe your debit card and sign at a credit card terminal to make a purchase. Online purchases with your debit card will also fall under this category.

#### Q. What will happen if I do not opt-in?

- A. Any one-time debit card transaction you try to process with insufficient funds in your account will be declined and you will need another way to pay for your purchase.
- O. How can I ensure that my one-time debit card transactions will not be declined and successfully post to my account?
- A. Submit your affirmative consent to permit CFCU<sup>SM</sup> to authorize and pay overdrafts on your one-time debit card transactions by stopping in at any of our office locations, or contact us via phone, email or mail.
